We are committed to improving and continually reviewing our practices where possible, to combat slavery and human trafficking.

ORGANISATION'S STRUCTURE

We are a provider of education and care services to children and adults with complex learning difficulties, challenging behaviour, autism and global development delay. We are a part of the Cedar Group, and our ultimate parent company is Cedar Project Holdco Limited ("Cedar"). Cedar has its head office in the UK. We have c1,000 employees.

We have annual turnover of c£45m.

OUR SUPPLY CHAINS

Education and care support is provided by our employees within properties which are owned by the group. There is no manufacturing or distribution involved.

OUR POLICIES ON SLAVERY AND HUMAN TRAFFICKING

We are committed to ensuring that there is no modern slavery or human trafficking in our supply chains or in any part of our business. We are committed to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and controls to ensure slavery and human trafficking is not taking place anywhere in our supply chains.

DUE DILIGENCE PROCESSES FOR SLAVERY AND HUMAN TRAFFICKING

As part of our initiative to identify and mitigate risk we ensure that our recruitment practices follow appropriate guidelines. This involves 'safer recruitment' under Ofsted guidelines by a defined recruitment team which is separate to the HR compliance team. All employees are subject to DBS and right to work checks. Our dealings with other suppliers include building contractors, suppliers of food, domestic supplies and office supplies. In respect of these parties we have in place systems to:

- Identify and assess potential risk areas in our supply chains.
- Mitigate the risk of slavery and human trafficking occurring in our supply chains.
- Monitor potential risk areas in our supply chains.
- Protect whistle blowers.

SUPPLIER ADHERENCE TO OUR VALUES

We have zero tolerance to slavery and human trafficking. To ensure all those in our supply chain and contractors comply with our values we maintain senior relationship contact with all our suppliers.

This involves director oversight and consists of involvement from the following departments as relevant: HR, finance (procurement) and external legal review.
